# INTERPRETIVE COMMITTEE

Report for April 2021

# Educational Videos

As part of an on-going project between the Interdisciplinary Humanities Center at UCSB and NSRM, I have produced a series of educational and informative videos for the museum's use. While these videos are currently hosted on my account, once Adam and the museum are happy with the finished content, they will be transferred to the museum to be uploaded on their YouTube page and disseminated to the public via social media and other outreach methods as they see fit. I have provided a brief description of each video along with links to view the completed drafts.

## Preparing a Steam Locomotive for Operation

This video follows crews of V&T #25 and the *Glenbrook* as they prepare their locomotives for operation. The video addresses lighting off, oiling around the locomotives, filling the hydrostatic lubricator and its purpose, reaching pressure, and blowing out the cylinder cocks. #### How a Steam Locomotive Works

Chris DeWitt explains how a steam locomotive works by utilizing a scale model next to the *Inyo* and explaining the process of steam filling the steam chest, being admitted into the cylinder, pushing the piston and creating the force to move the drive rod and turn the wheels before exhausting out the stack. #### The Science Behind a Wood Locomotive

# Preserving the Past


This video will explore why museums embark on missions of preservation, conservation, and restoration. Production of this video is in progress.

Using archival photos, this video explores the development of industrial infrastructure to fell a tree in the Sierras and bring it to market in Virginia City. Production of this video is in progress.


# Junior Conductor Program

I am working with Cristol and Adam to develop a junior conductor program targeting children ages 5-12 that visit the museum. Mirroring the successful junior ranger program offered by the National Park Service, this program will offer young visitors to the museum a booklet to complete as they make their way through the museum. The booklet will contain a mixture of educational tasks, puzzles, a scavenger hunt, and artistic options to be completed and turned in at the end of their visit—or perhaps filled out over the course of multiple visits. Benchmarks will be set concerning the amount of the booklet necessary for successful completion based on age. Upon completion, these guests will be given a junior conductor badge. Taylor McCready has generously rendered my design into a model for 3D printing (see image below). I plan to print several hundred of these for the museum's use once the program is ready to go live.



# School Railroad Construction Kits

Working with Taylor McCready, I have developed a kit that can be 3D printed and sent to fourth grade students as part of a lesson plan on the Transcontinental Railroad and the process of railroad construction. Students will be provided the necessary components to build a section of track approximately one foot in length that they will assemble following the track laying video that accompanies the lesson. These materials will be printed and made available to Adam and the museum's use once the program is ready to go live.



# Painting V&T Coach/Caboose 8

Once Dan gives the final authorization, I will work with Kevin, Chris, and Wendell to begin the process of repainting Coach/Caboose 8 to a historically accurate schematic. We have tentatively chosen its final day scheme allowing us to interpret the final years on the Virginia and Truckee. Painting will likely occur over the summer if authorization is given. Loren Jahn believes he can get historically accurate oil-based paints donated for the project, and I will work with him to ensure these paints match to our informed guess on the appropriate livery of the car from 1947. Painting will likely occur over summer assuming museum staff give the anticipated authorization.

# Depot Interpretation

I have begun discussions with Adam about long-term planning for better interpreting the Wasbuska Depot. This includes informative signs outside the depot, water tower, and Nelson House for guests to read that inform them of their history and use. We are also going to begin the process of determining a time period to present the depot's interior in and ensure the ticket office, waiting room, and freight rooms match this period.

# Temporary Exhibit

Adam and I are examining the possibility of creating a temporary exhibit exploring the use of motorcars on Nevada's railways to be housed in the depot's freight room. Utilizing the freight room affords the space for such an exhibit, provides educational activities for guests waiting for passenger trains and motorcars (when utilizing the depot), and encourages guests to move around the property. Discussion is in the early stages and may or may not materialize this year.
